**CALL TO ORDER**

Meeting called to order at 6:00 PM with the Pledge of Allegiance led by Supervisor Rau.

**APPROVAL OF AGENDA**

**A motion was made by Benedetti and supported by Dobis to approve the agenda as amended. MOTION CARRIED, 7-0.**

**NEW BUSINESS**

1. Retirement Plan: Clint Rux - Edward Jones, was present, to answer questions on a Simple IRA retirement account for staff and officials. Trustee Klein asked Supervisor Rau to obtain a legal opinion as to offering a retirement plan to part-time employees and elected officials.
2. Staff and Elected Official Compensation: **A motion was made by McCloskey and supported by Klein to maintain the 2003-2004 salary of \$25,500 for Clerk, Supervisor and Treasurer and \$2,500 for the Trustees. Roll Call Vote: Yeas: McCloskey, Benedetti, Buerman, Dobis and Klein. Nays: Guyon and Rau. MOTION CARRIED.**  
**A motion was made by McCloskey and supported by Klein to increase staff hourly rates by 3%: Zoning Administrator - \$16.50 to \$17.33; Deputy Clerk - \$15.00 to \$15.75; Deputy Treasurer - \$19.15 to \$20.11; Receptionist \$10.00 to \$10.50; Senior Director \$11.50 to \$12.07. Roll Call Vote: Yeas: McCloskey, Benedetti, Dobis, Guyon, Rau and Klein. Nays: Buerman. MOTION CARRIED.**  
**A motion was made by Klein and supported by Rau to pay the Board of Trustees \$75 for special meetings. Roll Call Vote: Yeas: McCloskey, Dobis, Rau and Klein. Nays: Guyon, Buerman and Benedetti. MOTION CARRIED.**
3. Draft 2008-2009 Budget Workshop: Board discussed the budget in preparation for the Budget Hearing during the regular meeting 6/18/08.
